## **PRESIDENT & PROVOST OF UCL**



***Dr Michael Spence***

Dr Spence joined UCL during the COVID-19 pandemic, leading the institution through the complexities of reopening and transitioning back to in-person learning following the national lockdowns. Since joining he has led a year-long university-wide consultation to develop the UCL Strategic Plan 2022-27, setting out UCL's priorities and ambitions for that period, and overseen the relaunch of UCL's Grand Challenges programme, supporting the academic community to work together on cross-cutting, multidisciplinary solutions to the world's most complex issues.

During a challenging time for the HE sector, and a wider cost of living crisis, his focus on financial sustainability has enabled UCL to make significant investment to attract and retain world-class talent. During his tenure, UCL's reputation as an academic powerhouse has also grown, with accolades including Sunday Times University of the Year 2024.

He has also overseen the opening of UCL East, UCL's major new campus in East London, building key strategic relationships with local government, businesses and community organisations in that area. Furthermore, through his work with UCL's philanthropic community he has played a direct role in supporting an increase in philanthropic gifts to UCL, with £235.6 million raised in 2023-24.

As a long-standing proponent of universities as crucibles for debate and dialogue, he has established himself as a leading voice within the UK and beyond promoting the art of 'disagreeing well' and is spearheading a new programme of activities at UCL which explore approaches to developing the skill of constructive debate around challenging issues.



## INTRODUCTION

After sustained economic growth and urbanisation, China came to a critical historical moment. In the post-pandemic era, China encountered an economic slowdown, a property market downturn, increasing debts, and intensified geopolitical tensions. Its world factory development regime is under profound challenges. Land-financed infrastructure-led urbanisation can no longer be sustained. Entrepreneurial urban governance is transformed by expanding state intervention. In conjunction with United Nations Sustainable Development Goals (SDGs), China targets 'carbon peak and carbon neutrality' and 'high-quality development' and pursues 'Chinese-style modernisation'. It is timely to re-examine China's urban development and governance in the context of global urban transformation.

Following a series of International Conferences on China's Urban Development in Hong Kong, Cardiff, Shanghai, London, Glasgow, and Manchester, the conference will return to London in 2025 to place Chinese cities in a changing world and engage with a wider urban studies community. The conference is organised with the project 'Rethinking China's Model of Urban Governance', funded by the European Research Council (ERC Advanced Grant). It provides a forum for dialogue on China's broad political, economic, social, and environmental challenges and governance. It also welcomes papers focusing on urban development and governance in other regions.

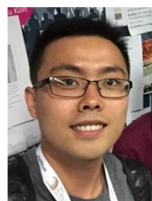

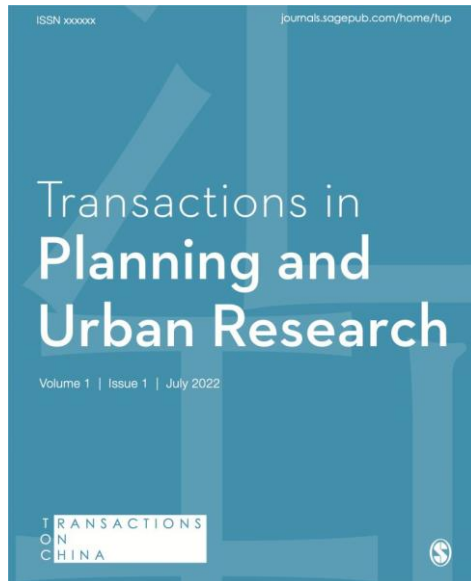

### Journal overview

China's massively accelerated urbanization presents a laboratory for researchers to observe economic, social, and governance changes in the contemporary world. To understand Chinese urbanization requires both contextual and comparative research. Known as "Urban China Research" in Planning and Urban Studies, this research field is growing rapidly. It is situated in the conjuncture of China Studies oriented towards historical, cultural, and political contexts and Planning and Urban Studies treating Chinese urbanization as part of political, economic, and social changes in the globalizing world. *Transactions in Planning and Urban Research* will make an original contribution to academic and policy debate related to the phenomenal urban development of China. In addition to investigating historical and geographical processes of Chinese development, the journal explores urban China in the wider global context and seeks meaningful connection between interpretative analysis and planning policy development. The journal publishes peer-reviewed academic papers of around 8500 words that affect Chinese urban and regional development. The journal will focus on recent developments in China, and their policy implications, while situating the research in comparative perspectives within wider processes as appropriate.

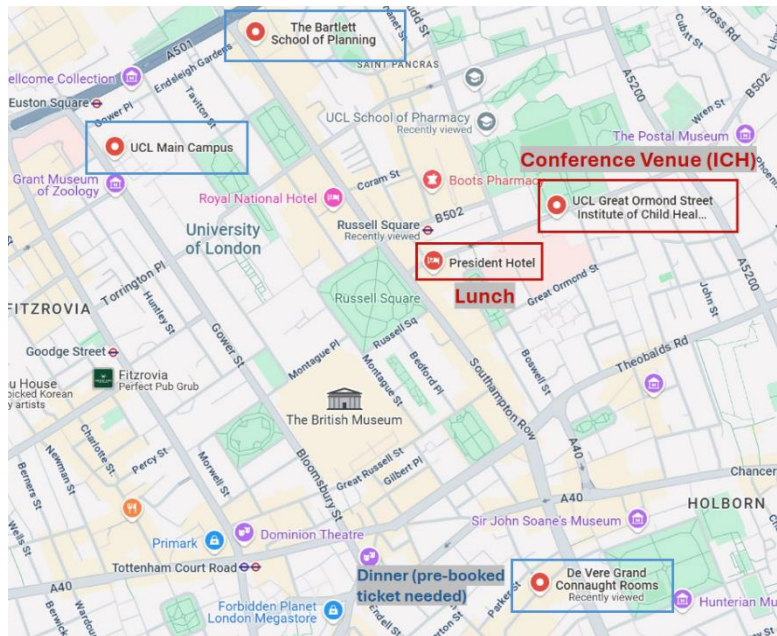

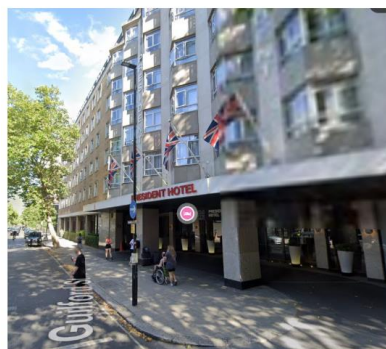

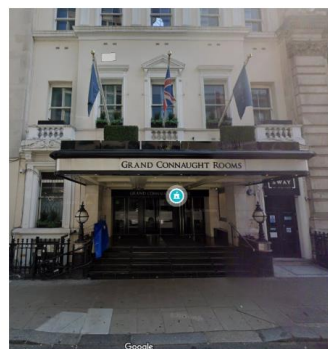

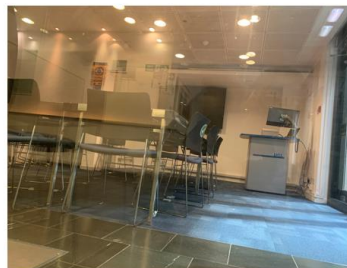

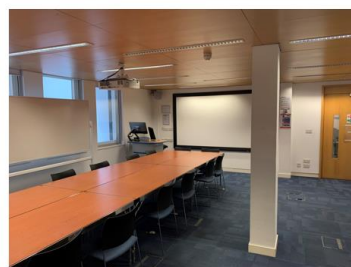

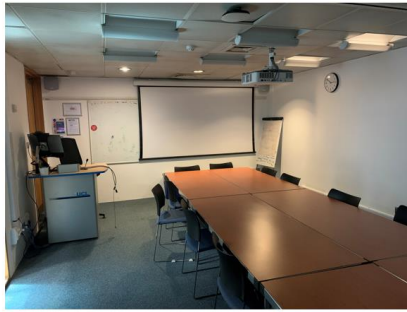

## KEYNOTES AND PANELLISTS

***Prof. Anthony G.O. Yeh***



***Chair Professor, Department of Urban Planning and Design, The University of Hong Kong***

Prof. Anthony G.O. Yeh, *FHKIP, FRTPI, FPIA, FRICS, FCILT and Hon FHKIS*. Member of the Chinese Academy of Sciences and Hong Kong Academy of Sciences and Fellow of TWAS (The World Academy of Sciences) and Academy of Social Sciences UK is Chan To-Hann Professor in Urban Planning and Design and Chair Professor of Department of Urban Planning and Design and Director of GIS Research Centre, and former Dean of Graduate School, Director of Centre of Urban Studies and Urban Planning, Institute of Transport Studies, and Head of Department of Urban Planning and Design at the University of Hong Kong. His main areas of specialisation are in the applications of geographic information systems (GIS) as planning support system in smart city and urban development and planning in Hong Kong, China, and South East Asia. He received the UN-HABITAT Lecture Award in 2008 for his outstanding and sustained contribution to research, thinking and practice in the human settlements field. He has published over 30 books and monographs and over 180 international journal papers and book chapters. He also serves as editorial board members in major international journals and honorary professors and external examiners of a number of universities and research institutes in China and S.E. Asia. He has been President of Asia GIS Association, Founding Secretary-General of the Asian Planning Schools Association and Asia GIS Association, Founding President of the Hong Kong GIS Association, Chairman of the Hong Kong Geographical Association, Vice-President of the Commonwealth Association of Planners, Vice-President of the Hong Kong Institute of Planners, and Chairman of the Geographic Information Science Commission of the International Geographic Union (IGU).

### **Abstract for The Opening Keynote Presentation**

#### **Smart Technology and Urban Governance**

Recent big advancement in smart technologies, such as sensors, digital twin, and generative AI, has great impacts on urban governance. Urban government has evolved from e-government in the 2000s to the present smart digital-government. Smart technologies have made cities to be more sustainable, efficient and convenient and much safer. However, can it resolve the fundamental problems of resource allocation and citizens in conflicts in urban governance?



**Prof. Jamie Peck**

**University Killam Professor, Department of Geography, University of British Columbia, Canada**

Jamie Peck, FRSC, FBA, FAcSS is University Killam Professor, Distinguished University Scholar and Professor of Geography at the University of British Columbia, Canada. With long-term research interests in economic geography, urban and regional studies, and institutional political economy, he is the author most recently of *Variegated economies* (2023, Oxford). *Jamie Peck* is the Managing Editor of the journal *EPA: Economy & Space* and the founder of the Summer Institute in Economic Geography.

### **Abstract for The Opening Keynote Presentation**

#### **Party-state capitalism on the edge**

Usually indexed exclusively to China, the concept of party-state capitalism has been gaining currency of late, both among heterodox think tanks and in academic circles, and for the most part in the West. The presentation will explore what it means to engage and problematise the concept of party-state capitalism, not as a regime type, “variety” or proxy for the “China model,” but as an open theoretical and methodological question. To do so involves making the case for, while also confronting challenges to, reworked approaches to conjunctural analysis, which have potentially significant roles to play in urban and regional studies.



**Prof. Michael Batty**

***Emeritus Bartlett Professor of Planning at University College London and Chair of the Centre for Advanced Spatial Analysis (CASA)***

Michael Batty, CBE, FRS, FBA, FAcSS is Emeritus Bartlett Professor of Planning at University College London and Chair of the Centre for Advanced Spatial Analysis (CASA). He is a graduate of the University of Manchester in Town and Country Planning and of the University of Wales Institute of Science and Technology in Architecture where he was Professor of Town Planning in the 1980s. He was Director of the National Center for Geographic Information and Analysis (NCGIA) at SUNY-Buffalo from 1990 to 1995 before he set up CASA at UCL. He is a Fellow of the British Academy (FBA), Royal Society (FRS), Academy of Social Sciences (FAcSS), Royal Town Planning Institute (RTPI), Chartered Institute of Logistics and Transport (FCILT), Royal Society of Arts (FRSA), and the Royal Geographical Society (FRGS).

He has worked on data analysis and computer models of cities and their visualisation since the 1970s. His recent publications are ***Cities and Complexity*** (2005), ***The New Science of Cities*** (2013), ***Inventing Future Cities*** (2018), and ***The Computable City*** (2024), all from The MIT Press. His edited book ***Urban Informatics*** (Springer 2021) reflects his focus on the applications of digital and geospatial technologies to urban planning. He also co-authored ***A Digital Future for Planning***, <https://digital4planning.com>, the Report on Digital Taskforce for Planning (2022). He is one of the most highly cited urban planners (Google H=120).

He was awarded the CBE in the Queen's Birthday Honours List in 2004, the Lauréat Prix International de Géographie Vautrin Lud ('Nobel de Géographie') in 2013, the Gold Medal of the Royal Geographical Society in 2015, and the Gold Medal of the Royal Town Planning Institute in 2016. He has honorary doctorate degrees from SUNY-Buffalo, the University of Leicester, the Baptist University of Hong Kong, and the City University of Macau. In 2022 was elected as a Fellow of the Geographical Society of China and as a foreign Academician of the Chinese Academy of Sciences in 2023. He has had extensive experience of geospatial technologies from his directorships of the NSF NCGIA and then the Centre for Advanced Spatial Analysis at UCL. He was a member of the Computer Board, the ESRC and EPSRC Research Boards, Chair of the ESRC-JISC Census Advisory Committee (2001-2011), a member of the Advisory Panel on Public Sector Information (APPSI Ministry of Justice 2003-2010), a Fellow of the Alan Turing Institute (2019-2024), and a member of the STFC DAFNI Strategy Board.

## **Abstract for The TPUR Plenary Forum I**

### **Cities of the Future in an Artificially Intelligent World**

Cities are very largely the product of our own creative efforts at organising production and consumption in ways that are designed to accelerate our collective prosperity. From classical times if not before, cities have been largely physical in conception providing frameworks for allocating resources to different human activities but until the industrial revolution which began in western Europe in about 1740, most human activity involved manual construction whose automation was primitive compared to what has happened since (Batty, 2024)<sup>1</sup>. Mechanical technologies first appeared leading to new forms of mobility based on conventional energies, but these were quickly supplemented by electrical then digital increasingly based on communicating information and data across a massive proliferation of network cultures (Meier, 1962)<sup>2</sup>. The urban world is rapidly becoming virtual as physical communications merge with digital, and as human activities are no longer generated in traditional mechanistic ways. Here we will sketch out how we see this future by painting a picture of how we will communicate in the future using various forms of AI and how cities will become ever more automated, if not in physical terms, in terms of the software used to supplement and complement urban life.

***Prof. Cecilia Wong***

***Professor of Spatial Planning, Co-Director of Policy@Manchester, Director of Spatial Policy & Analysis Lab and Research Director of Planning, Property and Environmental Management Department at The University of Manchester***

Cecilia is Professor of Spatial Planning, Co-Director of Policy@Manchester, Director of Spatial Policy & Analysis Lab and Research Director of Planning, Property and Environmental Management Department at the University of Manchester. She is a Fellow of the Royal Town Planning Institute and the Academy of Social Sciences. Cecilia has recently taken up the role as the Chair of the UK2070 Commission to promote regional and spatial equality across the UK and a Member of the UK Economic and Social Research Council. Her research expertise includes strategic planning, spatial policy monitoring and analysis, urban and regional development, and housing and infrastructure planning. She has recently completed a five-year consortium project on 'Tackling root causes upstream of unhealthy urban development' funded by the UK Prevention Research Partnership.

### **Abstract for The TPUR Plenary Forum I**

#### **Challenges of spatial planning in uncertain times**

The presentation will reflect on the recent whirlwind of planning and infrastructure reforms and the renewal of interest in some old planning ideas of building new towns and having strategic planning in Britain. These radical reforms are proposed at a time of uncertainties when the UK has been undergoing major economic pressure and the impacts brought by global political events. This then raises some interesting questions over how academics should frame their research questions and adopt different methodological approaches to understand the dynamic and fluid changes to our people and places. By drawing out the emerging trends and observations in the British context, the presentation aims to share some ideas and compare them with the directions of travel of Chinese urban planning research.



**Prof. David Wilson**

**Professor of Geography, Department of Geography,  
University of Illinois Urbana-Champaign, USA**

David Wilson is Professor of Geography, Urban Planning and the Unit for Criticism and Interpretive Theory at the University of Illinois Urbana-Champaign, USA. His recent work on cities of the global north and global south has examined new forms of governance and their impacts on cities, the relations between urban politics and the growth of slums and ghettos, and new modes of urban redevelopment. His most recent books are *Toward a Dracula Urbanism: Smart Cities and Urban Change in the Twenty-First Century* (with Elvin Wyly, London, Routledge) 2025, in press; *Chicago's New Racial Redevelopment Machine and South Side Blues Clubs* (New York: Palgrave-MacMillan) 2018; and *The Handbook on Spaces of Urban Politics* (with K. Ward, A. Jonas, and B. Miller, London, Routledge) 2018.

### **Abstract for The TPUR Plenary Forum I**

#### **Dracula Urbanism and Chinese City Change: A Prognosis**

Chinese cities, from Shanghai to Beijing to Wuhan to Chengdu, currently find themselves in an emergent reality of fast capitalist processes, exploding growth, growing private sector political influence, smart city ascendancy, and rising public-private partnerships. These always developing cities, not surprisingly, experience the likes of growing gulfs between rich and poor, accelerating residential dislocation of the politically vulnerable, and increased investment in downtowns to the exclusion of other city parts. This paper examines the relevance of the recent Dracula urbanism hypothesis for understanding the ongoing development of Chinese cities. Initially, four central tenets of Dracula urbanism are outlined: social exclusions and social-kill-offs of the poor accelerate, development governance is increasingly parasitic in forging alliances to facilitate development, decline emerges as a key resource to drive development, and development operations are increasingly planetary in reach and constitution. Then, the relevance of these points for understanding current Chinese urbanism is explored. The results suggest that numerous Chinese cities can be seen to be following a Dracula-esque pattern of development. This seeming development paradigm has relevance especially for large, global-reaching and global-aspiring cities in China. Also shown: Dracula urbanism, applying a monster metaphor to comprehend the specifics of urban processes, is a complicated epistemological template that imposes key silences and omissions as well as illuminates key insights about current city development in China. Of particular concern here: such “monstrous” abstractions can foster a kind of suppression, imposing the wholes of monster “units” which cast away nuances, complexities, and important heterogeneities. All in all, I conclude, more conceptual and empirical work needs to be done to forge definitive conclusions about Dracula urbanism’s applicability to Chinese urbanisation.





***Prof. Max D. Woodworth***

Max D. Woodworth is a geographer who works at the intersections of city development, cultural studies, energy, and geopolitics. His research, to date, has focused on the politics of city-making projects in China, energy boomtowns around the world, and master-planned new cities. He is currently researching Cold War military enclaves in Taiwan and U.S. President Trump's still-forming plans to construct chartered "Freedom Cities."

#### **Abstract for The TPUR Plenary Forum I**

##### **Who Speaks for China Urban Studies?**

Global urban studies has been roiled by a lively debate over urban theory and its connections to cities in the Global North and Global South. At stake are questions of epistemology, method, inclusion, and representation. But, more important, ongoing debates about urban theory are about power—power in knowledge production, power in the channels of knowledge exchange, power in the locations of research funding and institutional support, power in the deep legacies of uneven political relations that spill into scholarly realms. Recent debates in TPUR have helped to raise these issues in relation to China urban studies. These propose a set of methodological propositions aimed at "building theory in and through urban China." We are hearing about comparative urbanism, theory from the South, a worlding of cities, and a decolonisation of knowledge. What are the prospects for these dynamics in China urban studies? Where would changes in the field take us? How can the field be imagined differently? In this paper, I frame a review of the field's knowledge-production trajectory by centering the problem of power in its new and old guises.



**Prof. Shenjing He**

***Lady Edith Kotewall Professor in the Built Environment, Head of the Department of Urban Planning and Design, The University of Hong Kong***

Shenjing He is Lady Edith Kotewall Professor in the Built Environment, Head of the Department of Urban Planning and Design, and Founding Director of the Social Infrastructure for Equity and Well-being (SIEW Lab) at the University of Hong Kong. She has published widely on topics of urban redevelopment/ gentrification, urban and regional governance, urban-rural interface, housing and well-being, and healthy cities. Since 2023, she has served as Co-Editor-in-Chief for Area Development and Policy, and from 2012 to 2024 as an editor for Urban Studies. At SIEW Lab, she leads multiple research projects on urban and regional governance in the Greater Bay Area, education-featured gated communities, multi-dimensional housing inequalities in megacities, rural revitalization and conservation in Hong Kong.

### **Abstract for The TPUR Plenary Forum II**

#### **Towards co-governance? Emergent norms and forms of neighbourhood governance in urban China**

Portraited as the ‘last mile’ and ‘basic unit’ of social governance in Chinese official discourses, the neighbourhood has recently gained unprecedented importance in Chinese cities. Active neighbourhood participation and multi-actor collaboration, known as ‘neighbourhood co-governance’, become the new norm in both discourse and practice. In the past decade, three major forms of neighbourhood co-governance have emerged: state-led co-creation, professional-led place-making, and enterprise-party co-development, led by the local state, societal actors, and market actors respectively. Not only the leading actors in each type of co-governance matter, but also the configuration of the governing structure, i.e., the roles of key stakeholders and their power relations, is essential to understanding the variegated forms of neighbourhood co-governance. This research brings together multiple theoretical lenses, namely the state project of crisis management, state infrastructural power, and state entrepreneurialism, to scrutinize the emerging norms and forms of neighbourhood governance. The rise of neighbourhood co-governance in Chinese cities can be conceptualized as an enactment of a distinctive entrepreneurial state project that serves the purpose of crisis management through consolidating state infrastructure power, delivering governance goals, and practicing entrepreneurial governance at the neighbourhood level.



***Prof. Hyun Bang Shin***

***Professor of Geography and Urban Studies and Head of the Department of Geography and Environment at the London School of Economics and Political Science.***

Hyun Bang Shin is Professor of Geography and Urban Studies and Head of the Department of Geography and Environment at the London School of Economics and Political Science. Elected Fellow of the Academy of Social Sciences in the UK, Professor Shin has contributed to reshaping the understanding of contemporary urban transformation, emphasising the socio-political dynamics of cities in rapidly developing regions, particularly in East and Southeast Asia. From 2018 to 2023, he served as Director of the Saw Swee Hock Southeast Asia Centre at LSE, fostering interdisciplinary research on Asia. He was the Editor of the International Journal of Urban and Regional Research from 2021 to 2024 and a trustee of the Urban Studies Foundation from 2016 to 2023, contributing to global urban scholarship and mentorship. Since 2009, he has co-organised The Urban Salon, a London-based forum for architecture, cities, and international urbanism.

### **Abstract for The *TPUR* Plenary Forum II**

#### **Entrepreneurial Neo-managerialism: Revisiting Urban Governance in China**

Recently, China's central government initiated a series of social policies to alleviate social disparities, providing opportunities to revisit state entrepreneurialism, which is known to have long prevailed in China's urban governance since the economic reform. The talk asserts the importance of considering state entrepreneurialism in relation to the state's managerial pursuit. That is, an actually existing mode of urban governance may be characterised by the shifting dynamics between a managerial and entrepreneurial endeavour of the local state. In the context of a shrinking discretionary space under the power recentralisation of the central state that strives to avoid its legitimacy crisis, the local state, while still under the influence of its entrepreneurial logic of land-based accumulation, enhances its managerial role to respond to the top-down demands of social redistribution from the central state, devising a sophisticated redistributive mechanism of resource allocation.





***Prof. Jiang Xu***

***Professor and Head, Department of Geography and Resource Management, The Chinese University of Hong Kong***

Jiang Xu serves as the Chair and Professor in the Department of Geography and Resource Management at The Chinese University of Hong Kong (CUHK). Previously, she worked as a practitioner in an international consulting firm, gaining valuable experience in both China and Canada. Driven by a desire for a more intellectually stimulating career, she transitioned back to academia. Her primary research interests lie in critical urban and regional studies, particularly focusing on China's inland region and the Greater Bay Area. Recognized for her contributions, she has received numerous research awards and has widely published in leading international journals. In her recent works, Jiang Xu integrates the political economy tradition with a post-structuralist approach, offering a unique perspective on how emerging industries such as big data have influenced China's urban and regional transformation.

### **Abstract for The *TPUR* Plenary Forum II**

#### **Reconceptualizing Land Development in China: A Strategic Discursive-Material Nexus Approach**

China's land development is often perceived as a state-led model. This paper aims to deepen this understanding by examining it through the lens of a strategic discursive-material nexus, which integrates both the material processes of land development and the discursive processes of justification that highlight the diverse utilizations of land. We develop two key arguments by cross-fertilizing the economic sociology of land and cultural political economy. Firstly, the state strategically adjusts local land use and regimes to meet evolving geopolitical and political-economic imperatives. Secondly, due to the multiple affordances of land, various competing imaginations and interests have emerged, potentially hindering land (regime) change. Consequently, the state selectively represents land from a range of epistemological claims to justify institutional transformations and (re)development. These arguments are substantiated through an analysis of a big data economy-themed land development in China's Big Data Valley in Guizhou, the first national big data pilot zone.



**Prof. Fulong Wu**

***Bartlett Professor of Planning, The Bartlett School of Planning, University College London***

Professor Fulong Wu is a distinguished scholar in urban studies, currently serving as the Bartlett Professor of Planning at University College London. Before joining UCL in 2011, he held academic positions at the University of Southampton and Cardiff University.

Professor Wu's research focuses on urban development in China, addressing social and sustainability challenges. His notable publications include *Planning for Growth: Urban and Regional Planning in China* (2015), *Creating Chinese Urbanism: Urban Revolution and Governance Changes* (2022), and *Governing Urban Development in China: Critical Urban Studies* (2025), co-authored with Professor Fangzhu Zhang.

In 2013, he was awarded the Outstanding International Impact Prize by the UK's Economic and Social Research Council (ESRC). He was also featured in Clarivate's 1% Highly Cited Researchers List in social science in 2023 and 2024 and Stanford University's top 2% Scientists list (2020-24), highlighting his influential research.

He has secured £4.9 million in funding as Principal Investigator across 32 research projects to date. He currently leads an ERC Advanced Grant project, *Rethinking China's Model of Urban Governance*, reflecting his ongoing commitment to advancing scholarship on urbanisation and governance in China.

### **Abstract for The TPUR Plenary Forum II**

#### **From entrepreneurial to managerial statecraft: New trends of urban governance transformation in post-pandemic China**

The global financial crisis started a new context of late capitalism and austerity urbanism. Instead of a unidirectional governance transformation towards entrepreneurialism, rising finance and financialisation, pervasive state roles in

state capitalism and post-growth municipal radicalism are competing trends. Previously, China witnessed private entrepreneurship, economic devolution, and housing commodification at the turn of the millennium. They have been portrayed as urban or state entrepreneurialism. These governance features were transformed as China entered Xi Jinping's new era. This paper revisits the transformations in post-pandemic China and finds that rising state capital, re-centralisation of spatial governance and party-state co-governance represent the shift from entrepreneurial to managerial statecraft. The new trends broadly echo changing capital–state–society relationships in the world today. Beyond market rationality, the state mobilises capital and society to pursue strategic intentionality. The transformation has been exacerbated by pandemic urgency, post-pandemic economic downturn and greater geopolitical tension.

Chris Hamnett is Emeritus professor of geography at King's College London. He is currently visiting professor at Renmin UC, Beijing.

He is interested in the urbanization of China and the economic and social issues involved. He is a visiting professor in the Department of Urban Planning and Management, Renmin University, Beijing (2019-2024).

He has authored or co-authored books including *Cities, Housing and Profits* (1989), *Shrinking the State: the political underpinnings of privatization* (1998), *Winners and Losers: home ownership in modern Britain* (1999), *Unequal City: London in the global arena* (2003) and with Tim Butler *Ethnicity, Class and Aspiration: remaking London's New East End* (2011). His latest book is 'Gentrification: An advanced introduction' (2021) Edward Elgar.



***Prof. Zhigang Li***

***Professor, Dean of the School of Urban Design, Wuhan University***

Zhigang Li is a professor of urban studies and planning at the School of Urban Design at Wuhan University, China. He is a fellow of Academy of Social Sciences (FACSS). He works on China's urban transformation, focusing on topics such as neighborhoods, migration, and planning. His recent work concentrates on urban redevelopment, resilient cities, and related governance issues for megacities such as Wuhan, Guangzhou, and Shanghai.



***Prof. Fangzhu Zhang***

***Professor of China Planning, The Bartlett  
School of Planning, University College London***

Fangzhu Zhang is a professor of China planning and a joint coordinator for the China Planning Research Group at the Bartlett School of Planning, University College London (UCL), UK. Her main research interests focus on innovation and governance; environmental planning and eco-city development; urban financialisation; and urban village redevelopment and migrant integration in China. She has published articles extensively in leading international journals and is a guest editor for special issues of several journals such as *Town Planning Review* (2008); *Urban Studies* (2020); *Land Use Policy* (2021); *TPUR* (2023,2024). She is also co-editor of the book *“Handbook on China’s Urban Environmental Governance* (Edward Elgar, 2023) and co-author of the book *“Governing Urban Development in China: Critical Urban Studies* (Routledge, 2025). She has been involved in several research projects funded by the British Academy, ESRC (UK) and the EU. She is the founding Editor-in-Chief of the journal entitled *“Transactions in Planning and Urban Research” (TPUR)*. Currently, she is working on the ERC Advanced Grant research project, Rethinking China’s Urban Governance (ChinaUrban, 2020-2026).



***Prof. Yang Xiao***

***Professor, College of Architecture and Urban Planning, Tongji University***

Yang Xiao is a tenured Professor and Deputy Head of Department at the College of Architecture and Urban Planning, Tongji University. He is listed on the Stanford University's Top 2% Scientist ranking list in 2023 and 2024. Yang's research interests include environmental justice, social equity, gentrification and AI-urban analytics. His research has been funded by the Chinese National Natural Science Foundation, National Social Science Foundation, and Economic and Social Research Council. Xiao has published over 100 articles in top Chinese and English SSCI and SCI journals and seven of his articles have been selected as ESI highly ranked articles. He seconded the deputy head of department of the Shanghai Huangpu District planning and natural resources department between 2018 – 2019. Yang is currently the associate editor at the Transactions in Planning and Urban Research, section editor of Land and section editor of Nature Human and Social Science Communications.





***Dr. Zheng Wang***

***Lecturer in Sustainable Cities, Department of Geography, King's College London***

Zheng Wang is a lecturer in Sustainable Cities at the Department of Geography, King's College London. Zheng is an urban geographer specialising in the politics and social consequences of urban (re)development. This includes identifying and explaining the variegated processes underpinning the development of mega urban projects, and the social outcomes and possibilities that arise as a result. His work takes urban China as a critical site to develop theoretical insights for a more global urban studies. Zheng is also an associate editor of *Transactions in Planning and Urban Research*. He is the recipient of the RTPI Early Career Award 2017 and has published in journals including *Dialogues in Human Geography*, *Antipode*, *Environment and Planning A*, *International Journal of Urban and Regional Research* and *Urban Studies*. His research has been funded by the British Academy and the Economic and Social Research Council. Zheng's latest research examines the long-term social impacts and community rebuilding efforts of mega urban projects in urban China.

UCLGuest is UCL's Wi-Fi (wireless) service designed to give external visitors internet access.

## TRANSPORT

You may download Google Map or Citymapper for directions. **Transport for London (TfL)** also has its app named TfL GO. It contains live transport information. Other apps may be not able to update live information as fast as TfL GO.

### Airport:

London has multiple airports, including

- London Heathrow Airport
- London City Airport
- Gatwick Airport
- Luton Airport, Stansted Airport, and Southend Airport.

The conference venues are at the centre of London, so they are easily accessible from all these airports. **Heathrow** is likely to be the main choice as there are many more choices there than in other airports. Except Heathrow and London City Airport, the rest is in outer London, and you may need to travel by train to the conference venues.

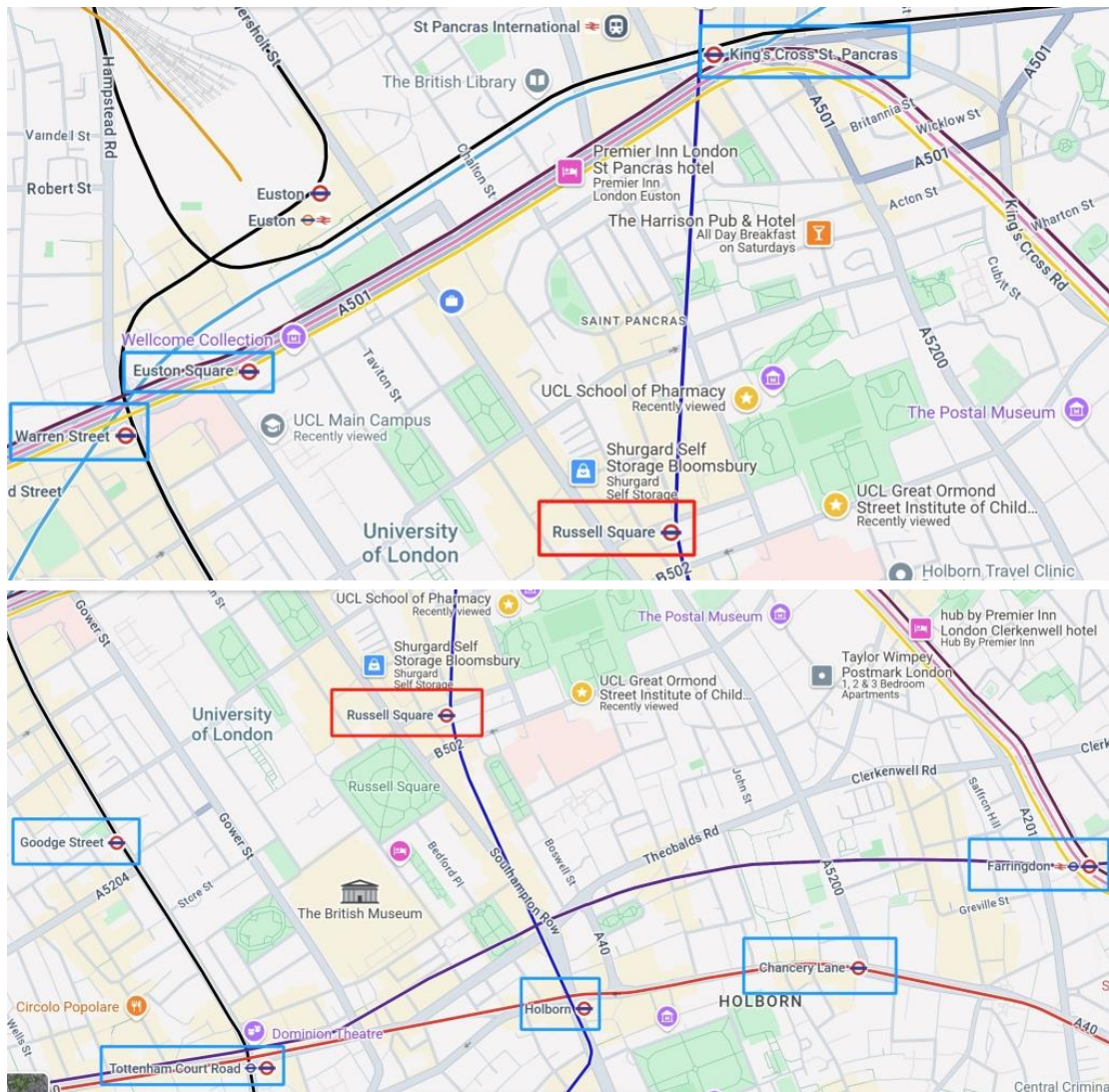
The easiest way from Heathrow to the conference venues is to take **Piccadilly Line from Heathrow to Russell Square**. You may plan you journey from/to Heathrow on its website: <https://www.heathrow.com/transport-and-directions/getting-to-central-london/journey-planner>

### Train:

The conference venues are close to several national and international railway stations, including **Euston, King's Cross and St. Pancras, Farrington**. These train stations are also underground stations and are mostly within a 20-minute walk to the venues (See the screenshot below).

### Public transport:

The nearest underground station is **Russell Square** (highlighted in red below), Bernard St, London WC1N 1LJ. It is a 5-minute walk to the conference venues. There are many other underground stations within a 15-20-minute walk including Euston, Euston Square, Holborn, etc (marked in blue below).



There are also bus stations nearby, including Tavistock Square, Russell Square, Southampton Row, etc.

### **Taxi:**

London's famous black cabs are easy to find around the conference venues. They usually operate in central London. They could be hailed on the street or booked in advance here at <https://tfl.gov.uk/modes/taxis-and-minicabs/book-a-taxi> The fee is £10 per mile on average, but it will be cheaper if you travel longer.

Uber operates in London, and you may download the app. Other platforms include Bolt, Gett, and others.
